# Fines for Natural resources-related offences

In unrelated matters, two men have received fines for natural resources-related offences.

In the first incident, court heard that resource management technicians discovered what appeared to be an unauthorized water crossing on a stream in Bordeleau Township. An investigation by a

conservation officer revealed that Michael Bean, 52, of Chapleau had constructed the bridge to access his trap line, but had failed to obtain the appropriate work permit from the Ministry of Natural Resources.

After being advised of the requirement for a permit, Bean

continued to make additions to the unauthorized bridge. He was fined \$500 under the Public Lands Act for working without a work permit and the bridge was removed.

In the second incident, a Gogama-area man has been fined \$350 for illegally harvesting logs from the Spanish Forest.

Marcel Hebert, 54, pleaded guilty to harvesting forest resources without a forest resource licence, a charge under the Crown Forest Sustainability Act. He will also pay the stumpage owed to the Crown.

Court heard that in November 2008, a conservation officer stopped Hebert with a load of 30 freshly-cut white cedar logs on a trailer. The logs were seized during the investigation.

Justice of the

Peace Murielle Quinn presided over both cases in the Ontario Court of Justice, Chapleau, on April 8, 2009.

The ministry reminds the public that staff is available to assist those who require permits and authorizations.



**Domestic Dispute**

On April 15, 2009 The OPP were dispatched to a Chapleau residence regarding an alleged Domestic Assault.

Investigation revealed that the male complainant had allegedly been assaulted by his girlfriend during the early morning hours by being punched in

the head with a closed fist followed by being struck with a lamp.

This resulted in minor injuries to the complainant. The female then attended the kitchen area and began throwing objects including knives at the complainant.

Although the complainant was not struck by these

objects, damage was caused to the interior of the residence as a result. It was further alleged that a quantity of pills were stolen by the suspect. As a result a 41 year old female was arrested and charged with the following Criminal Code offences;

- 1) Assault with a weapon
- 2) Assault
- 3) Possess Property Obtained by Crime
- 4) Fail to Comply with Undertaking x2
- 5) Mischief under \$5000.00
- 6) Theft under \$5000.00

**Assault, mischief**

On April 17 at approximately 3:15 am police on routine patrol observed a male subject who appeared to be intoxicated on Pine Street. When police approached the male he attempted to flee but was immediately apprehended. The subject then became quite violent and had to be restrained by the officers and placed in the rear of the police cruiser. As a result of this incident, Clayton QUACKEGESIC

stands charged with the following;

- 1) Mischief Under \$5000.00 x2 - Criminal Code
- 2) Assault Peace Officer - Criminal Code
- 3) Common Assault - Criminal Code
- 4) Breach of Probation - Criminal Code
- 5) Being Intoxicated in a Public Place under the Liquor Licence

Act.

He will appear in Chapleau Criminal Court at a later date to answer to the charges.

**R.I.D.E.** - Several RIDE/Seatbelt checks were conducted throughout the Superior East patrol area resulting in 400 vehicles being checked and 2 seatbelt charges being laid.

There were also three warnings under the Highway Traffic Act.

No other infractions were noted. The OPP remind all motorists to always wear your seatbelts while travelling on our roadways. Seatbelts do save lives and failure to wear your seatbelt can result in a \$110.00 fine and 2 demerit points.

# Is full-time cottage life for you?



It's a lifelong dream... the kids have grown up, left the nest, and after decades of work you're finally ready to retire. You've earned your place in the sun, and you're thinking of giving up the hectic city life to live full-time at the cottage.

"Canada's Income Tax Act allows us to claim one dwelling as a principal residence per-family-unit," says Chartered Accountant Philip Maguire, a principal in Glenidan Consultancy Ltd. in Toronto. "You must ordinarily inhabit the residence each year

for it to qualify as a principal residence. But if you're selling the house – or cottage, condo, mobile home or even a houseboat – you must designate one specific property to be your principal residence. Think this over carefully, because the money from the sale of all other properties will be subject to capital gains."

Capital gains tax applies to the difference between what you originally paid for the house and its value at the time you sell it (special rules apply if the house

was bought before 1972). If you've owned the home for some time, its value may have increased substantially. A full 50 per cent of that increase can be taxable.

There is a silver lining in that dark cloud. "If part of that increase in value is due to improvements you've made, the cost-base amount used to calculate the capital gains can be increased. The capital gains amount then decreases," explains Chartered Accountant John AbedRabbo of Polyzotis & Co. LLP in Toronto. "But those improvements must be real upgrades, not just normal maintenance. Keep receipts to back up your claims."

There's an added bonus for upgrading a home in 2009. The 2009 Federal budget introduced the home renovation tax credit (HRTC): up to \$1,350

for eligible expenditures between \$1,000 and \$10,000. The credit can apply to either the cottage or the house in town.

Beyond tax issues, there's a lot to consider if you're thinking of making the cottage your permanent home. "It really boils down to a personal decision," says Maguire, "and you should consider both your lifestyle and your needs as you get older."

"Living at the cottage might seem

like being on a permanent vacation, but consider the convenience factor, too," says AbedRabbo. "Is it easily accessible in winter time? Can you live there safely and comfortably? Are you able to find service people to repair the furnace or plow your private access road?"

Seniors especially should consider some of the health-related issues of living at the cottage. What about emergency services and the distance to the nearest

hospital? Will you be able to find a family doctor in the area, and get medication or treatment if and when you need it?

An impulsive decision can be costly, so be sure to carefully weigh your options. Talk to a Chartered Accountant about your specific residential situation, the tax implications and your future financial plans.

### TAKING CARE OF ONTARIO'S SENIORS

The Ontario government is working hard to ensure Ontario seniors enjoy a high quality of life by providing the health care and support they need in the ways that best meet their needs.

The 2009 budget includes a number of measures aimed to assist seniors:

#### **Doubling the Senior Homeowners' Property Tax Grant in 2010**

The Ontario Senior Homeowners' Property Tax Grant provides up to \$250 to help low- to middle-income senior homeowners pay their 2009 property tax. The maximum grant will be doubled to \$500 in 2010, helping more seniors remain in their own homes. Over the next five years, the grant will provide about \$1 billion in property tax relief to more than 600,000 seniors.

#### **Enhancing the Ontario Property and Sales Tax Credits for Senior Couples**

Since 2003, the government has made several improvements

to Ontario Property and Sales Tax Credits so they better reflect circumstances facing low-income seniors. Additional measures that would help senior couples include further enhancing the program to ensure senior couples receiving the guaranteed minimum level of income from governments would receive the full benefit from these credits.

#### **Increasing Access to Locked-In Accounts**

The government will continue to give seniors and other Ontarians more flexibility in accessing the funds in these accounts by proposing to: Increase unlocking permitted from Ontario life income funds from 25 per cent to 50 per cent; Provide a two-year waiver of fees for financial-hardship unlocking applications.


