## Legion receives Trillium Foundation grant

The Royal Canadian Legion Branch #5 was relieved to hear back in April that they were successful with their application to the Ontario Trillium Foundation. They were able to secure \$15,000.00 to be used to replace windows primarily on the top floor of the Legion building located at 33 Veterans Way. In all 23 windows will be replaced with new modern energy efficient windows.

The total cost of the project will be in excess of \$20,000 with the remaining balance being paid by the Legion Branch. The new windows should make a big difference in the Branch heating bill this winter. The Ontario Trillium Foundation has been around since 1982 and its funding is derived through Ontario Lotteries. This year alone 145 million dollars has been allocated to be distributed amongst Ontario

community groups and organizations via an application process. This was the Legions second application to the OTF and their first successful application with more planned for future projects. In keeping with the Legions community approach the windows were purchased locally and installed by a Chapleau contractor. Window installation started July 25th and is expected to be completed in a week.

## Soccer still Strong in Chapleau

The Chapleau Soccer League wrapped up the season for the U10 age groups June 21st, 2012. The number of registered players was phenomenal and we only have increased optimism for next year. The final registration numbers were 28 players in the 7-9 and 52 players in the 4-

6 divisions. The data also shows that 1/4 of our total registrations were children at the age of 4. All this data shows the future of soccer in Chapleau is bright. Increased registration enables us to have more teams, better field maintenance, lower overall fees, and better celebrations and special events.

This year also marked the return of 10-13 year olds soccer to Chapleau. This is a welcome change from previous years in which we were forced to cancel this group due to lack of registration. Data from Statistics Canada claims there are 125

children in Chapleau aged 10-14. These numbers alone indicate a meagre 19% participation rate. Clearly we need more than that for this group to survive next year. My hope is the running of the program this year will convince more youths to register next year.

The Chapleau Soccer League launched its new website over the summer: chapleau.soccer.ca. This web platform will be utilized in future seasons to allow registration over the Internet and the ability to pay registration fees by credit card. We also launched our

Facebook page as facebook.com/chapleausl. This is part of a broader strategy to attract youths from surrounding camps, communities, and resorts into participating in local, organized sports. One proud accomplishment this year was one registration all the way from British Columbia for a youth spending time in Chapleau visiting family.

Another few of our future initiatives will be the introduction of special discounts and an adjustment of player registration fees. As of this writing, the executive volunteers (EXVO's) have agreed in principle to

lower the registration fee from \$50 to \$40 assuming all budget targets are met at the end of the fiscal year. I hope to introduce two discounts for next season: a multi-player discount and the coach's discount. More details will emerge on our website as information becomes finalized. We will also make minor tweaks to the way uniform deposits are collected and reimbursed. The net benefit is a lower upfront cost to parents.

I also want to formally introduce myself. I am the new Chapleau Soccer League President, Tim Barnes. I started

coaching in this league eight years ago as a student. With a total of five years of coaching experience and one year as an organizer, I made the jump to the highest position at the start of this past season. Soccer is my passion and my love for it is only exceeded by my motivation to provide mentorship and entertainment to children. I own and operate my own computer repair company and sit on Chapleau's Leisure and Culture Services Committee. I work at the local electronics dealership during the day. At 22 years of age my work in this



# Beresford Greatheed, aka Greathead, visited 'city' of Chapleau while walking across Canada from Vancouver to Halifax in 1895

## Chapleau Moments

William James Percy Beresford Greatheed, aka Greathead, visited Chapleau in 1895 while walking across Canada from Vancouver to Halifax as part of a wager to walk around the world in five years.

In a letter to the Sudbury Journal of July 4, 1895, he signs it simply as Beresford Greatheed, but by 1904 when he appears to be still on a walking tour he has become "Professor" Beresford Greathead.

The story goes that in 1895 two clubs in Vancouver sponsored the around the world walk with the winner receiving \$50,000, an incredible amount at the time, if he completed it in five years. Greatheed was selected and off he went with no money, only the clothes on his back, no luggage except for a leather satchel containing his notebook, and a rifle with some ammunition.

His letter to the Sudbury Journal says he arrived in Chapleau and Mr. Mulligan - the very genial CPR agent welcomed me and showed me the various sights of the city."

"This place has a population of 500 souls and is built on a fine river."

To those who may already have doubts that Greatheed ever was in Chapleau, in 1895, the Mr. Mulligan to whom he refers was John George who was the Canadian Pacific Railway Dominion Express

Chapleau Agent, later renamed CPR Express. John was one of the four Mulligan brothers in Chapleau at the time -- Patrick ran Murrays and Mulligan general store: Thomas was the store's accountant; Charles was a carpenter, and John the Express agent.

My cousin Michael McMullen discovered the Greatheed story while doing research into our family at the Sudbury Public Library while we were on our way to Chapleau for the Chapleau High School reunion. Our respective grandmothers were members of the Mulligan family.

Although Chapleau had about 500 residents when Greatheed visited, he called it a city, and commented that it had "fine churches, CPR shops, three hotels, three or four good stores and numerous fine dwelling houses."

He paid particular attention to the Mechanics Institute, "a fine building erected in 1890 and has a hall where 300 persons could easily be seated - membership is 250 and each member paying \$2 per annum. Upstairs is occupied by various fraternal societies such as the Freemasons, Oddfellows, Knights of Pythians, Forresters, etc.

"A fine library exists here and most of the principal journals, magazines are ready for use of membership up until 10 p.m."

He gives great credit to president Mr. Kyle and vice president Mr. Mulligan for the "good order of things at the institute." It is quite likely that they had become the hosts for his visit as Greatheed had to rely on the generosity of people he met along the way.

He added: "I must not forget however, the polite caretaker whose name I failed to note."

The Mechanics Institute in Chapleau, and there were many across Canada and elsewhere was established by 1890 in a building across from the present Redwood Restaurant on Birch street. It had started as a Reading Club by 1887 and had evolved into the institute, according to research undertaken by George Evans. It burned down in 1910, and many files about the early years of the community were lost as it had also been used as the Town Hall.

However, in his letter to the Sudbury Journal, Greatheed is not so kind in his comments about the Canadian Pacific Railway.

He gives praise to the sectionmen who keep the track in good condition in this division of a "Mr. Kennedy" but that "taking into consideration the tremendous heat, black flies, mosquitoes, and a hundred other evils, the poor men deserve an increase in wages or at least their old pay restored. "These sectionmen have as much responsibility hanging over them if not more, than any other offered on the line, and I must say that I consider it very poor policy on the part of the CPR to treat them with such little consideration."

He promises to write more on this matter later.

Apparently Greatheed did walk across Canada from Vancouver to Halifax, a distance of about 4,000 miles in 12 months, and later walked in parts of Europe. I could not find evidence though that he won the \$50,000 prize. There is a reference to him as "the great walker" in The Amazing Foot Race of 1921: Halifax to Vancouver in 134 Days by Shirley

Jean Tucker.

However, he reappears in the December 31, 1904 issue of The Dispatch newspaper of Lexington, North Carolina, as Professor Beresford Greatheed, giving a lecture to a small but interested group about his journeys. It appears that he is now on a lecture tour of the United States.

He is now saying that his walk around the world started in 1898, and that

he has walked 40,000 miles. The article says he was 39 years old, six feet tall and 260 pounds, and spoke four languages.

Undoubtedly, William James Percy Beresford Greatheed, aka Greathead, was an interesting character, who shared his moments in Chapleau, on his way across Canada. Thanks to Michael McMullen for discovering the story. My email is mj.morris@live.ca

**REPORT from

The implications of the roof collapse at the Algo Centre Mall in Elliot Lake continue to come into focus. Beyond the tragedy that took two lives, there are hundreds of people who are out of work as many businesses and service offices suffered setbacks from the event as well. As you may or

may not know, I had just moved my office into the mall only a month before the tragedy struck. Like all others who worked in the mall, it would seem the office I shared with local MPP, Michael Mantha, could be lost. This is also a loss to many of the constituents we were working with on various issues.

**MP community office forced to move after mall tragedy**

The move to the mall was made to combine the office of the MP with that of the MPP. It was our desire to have a responsive office that would be able to help constituents in one space, whether their issues are federal or provincial. That goal was being met and our staff was only just seeing how they could make the office work best for everyone involved. Lost, however, is the entire infrastructure of the office and an unknown amount of information.

For many

constituents who we were working with, this won't be welcome news. Right now it is impossible to say what can be recreated from the many electronic trails and what was only available in file form inside the office and, as such, is not accessible. We are in the process of piecing together the hardware that will let us move forward and be able to resume work on those ongoing files. Over time we hope to be in contact with all those we were assisting.

I have arranged my constituency office

to be a human interface between constituents and the federal government with a focus on services and programs. My office assists constituents as they navigate the federal bureaucracy for things like passports, programs like employment insurance, Canada Student Loans, CPP, OAS, GIS and with intimidating departments like the Canada Revenue Agency. That list is by no means complete and there are hundreds of incidental things that the office will do to help the

community. While the loss of the office is a set-back for my staff and the constituents we serve, it did not take us very long to get back up and running in a temporary location (10 Paris Drive, Unit #1, Elliot Lake). We encourage anyone who has yet to be in contact with either my office or that of my provincial counterpart about their outstanding matters, to contact our offices in order to assist us in rebuilding their file. That way we can better address the matters at hand.

**Home canning keeps you in control of food quality**



(NC)—The pursuit to preserve the freshest fruit and vegetables is trendier than ever. By bottling a favourite recipe ourselves, we get full control of the source as well as the ingredients. Better still, as the harvesting time of year approaches, the ability to buy up lots of fresh picked farmer's produce – and dine on it for months to come – is a tasty way to cut the cost of nutritious wintertime groceries.

So what should first timers know about pickling, preserving, and canning?

“The process combines lots of creativity with practicality,” says Chef Emerie Brine at Bernardin, a popular source for canning information and recipes. “Home canning is no longer a survival necessity, but a way of showing individual flare with recipes for an array of fruit, juices, jams,

pickles, relishes, chutneys, sauces, vinegars and whole range soups, stews, and savouries.”

Doing it yourself does require the knowledge and the tools, but as Chef Emerie points out, step-by step guidance is a click away on the Bernardin website.

Practically speaking, he explains, canning is not complicated. It is a simple procedure that applies heat to food in a closed glass jar to interrupt the natural decaying that would otherwise take place. The air we breathe and all foods in their natural state contain microorganisms, such as molds, yeasts, bacteria and enzymes. Food spoils when these factors are not controlled. Proper and safe home canning procedures control the growth of spoilage microorganisms, allowing us to keep food beyond its normal storage period.

While alternatives are available, Emerie emphasizes that the safest way to preserve foods is through 'heat processing'.

“Heating the filled jars is the only way to change the atmospheric pressure, thus creating a vacuum seal that will keep your treasured contents safe,” he explained.

This process, according to tested, up-to-date home canning guidelines, includes:

Placing prepared food in mason jars that can be sealed airtight with specialized two-piece metal closures, called SNAPLID®.

Using the correct type of canner to heat the filled jars to

a designated temperature.

Maintaining this temperature for the time specified in tested recipes to destroy the spoilage microorganisms, inactive enzymes, and to properly vent air from the jars.

Cooling the jars adequately to allow lids to form a strong vacuum seal.

The website guidance also includes attention to the altitude at your home location. For example, when canning at elevations higher than 305 metres, specific heat processing adjustments must be made. More information, including a calendar of local workshops, is available online at [www.bernardin.ca](http://www.bernardin.ca).

The approved project description and plan for the aerial herbicide project is available for public inspection at the EACOM Timmins office located at 823 Birch Street South Timmins and on the MNR public website at [ontario.ca/forestplans](http://ontario.ca/forestplans) beginning July 16, 2012 until March 31, 2013 when the annual work schedule expires and throughout the one year duration of the annual work schedule. The Ontario Government Information Centres at Espanola, Chapleau, Sudbury and Timmins provide access to the Internet.

Interested and affected persons and organizations can arrange an appointment with MNR staff at the MNR Espanola, Chapleau or Gogama offices to discuss the aerial herbicide project.





Interested and affected persons and organizations can arrange an appointment with MNR staff at the MNR District or Area office to discuss the aerial herbicide project.




