Probe Mines make first public presentation

A well attended first public presentation

by Probe Mines was held last Monday at the Community Hall to update the community on the progress of the Borden Gold

Project.

Probe CEO David Palmer updated on the on-going economic studies that will continue over the next 2-3 years. "We felt that this was the right time to consult with the communities as early results of our studies are showing that there's potential for a viable mine at the Borden Gold site" said Mr. Palmer

The gold deposit which was confirmed in 2010 is part of more than 2100 mining stakes in the area. The exploration area is located 15 km from Chapleau and 1 km from Highway 101. A total of 110,000 metres of drilling has been done and the gold deposit is now estimated to be 4 million ounces.

The presentation included an overview of the gold mining process and touched on some

possible environmental and socioeconomic impacts as well as how these impacts will be managed. "Mining has come a long way in the past 30 years" said Palmer "it's a tightly regulated industry" he added. As an example he noted that Probe would have to post a bond with the Ministry of Northern Development and Mines to cover 100% of the cost of restoring the mine-site before being granted a permit to build the mine. The project is now in the preliminary economic stage which is stage two of eight.

The following are the remaining stages:
3. Pre-feasibility stage-6-12 months.
4. Feasibility stage-12 months
5. Environmental and social impact stage.
6. Construction stage -18 months.

7. Operation stage-estimated to be between 15 and 20 years.

8. Closure and rehabilitation stage.

It is evident that a lot of steps still have to be taken to get a definite mine opening but the future of our community certainly got brighter.

If and when the mine opens an estimated 1100 workers would be required during the construction phase of the mine. The number of employees needed to operate the mine is estimated to be between 150 and 250.

It is evident that some cottagers are concerned with the development around Borden Lake. These concerns were raised during the question and answer period and some concerns were alleviated.

Dear Mrs. Joyal:

This refers to your letter of February 11th, 2013, addressed to Mr. John Marginson, concerning your recent experience with VIA Rail Canada. It was forwarded to my attention for further handling.

First and foremost, please allow me to apologize for the delay and disruption in service on January 30" and February 13" between Chapleau and Sudbury. Unfortunately, mechanical malfunctions and operating difficulties beyond our control can occasionally, despite our best efforts, cause delays or force us to cancel a train.

This being said, alternate transportation should have been provided to Chapleau and other stations which are accessible by road, as per our protocol. This incident has been brought to the attention of the appropriate manager for internal follow-up with the staff involved. We deeply regret the inconvenience caused to you and your son-in-law on this occasion.

As a token of our concern, VIA offers a travel credit equivalent to 50% of the fare paid (before

tax) for the affected trip when this train is delayed by two hours or more. Insofar as the return portion of your trip is concerned, our records indicate that the unused portion of your ticket has been refunded.

In view of the particular circumstances of your trip, we have exceptionally increased your credit to 100% and have also added \$30.00 for a total credit of \$60.00. The enclosed certificate is valid one year, is transferable and may be presented at any VIA ticketing office.

Again, I am very sorry for the difficulties caused to you as a result of these exceptional circumstances. We value your business and hope that we will have the opportunity to serve you again soon, albeit under better circumstances.



Randy Carroll, Michael Tremblay score winning goals as Chapleau Midget Huskies in great team effort win NOHA championship in 1979

The Chapleau Midget Huskies went all out to defeat Blind River for the Northern Ontario Hockey Association Midget "C" championship winning the best of three series in two thrilling straight games in 1979.

And as there was no Midget "C" category in southern Ontario, it gave the team bragging rights as the all-Ontario champions.

Playing on Easter weekend, it didn't look good for the Huskies in the first game as they fell behind Blind River 4-0 early in the first period, but David Freeborn followed by Yves Gervais put them on the scoreboard.

The Chapleau Sentinel account of the games kindly provided to me by team member Dan Tebbutt, relates that in the second period "hot goaltending" by Shane Gillham making "key saves" kept the Huskies in the game and the second period ended with them behind 5-3.

A determined effort in the third led to the game ending in a 6-6 tie with John Bernier and Geoffrey Hong both scoring. The story leaves out who scored two goals but I am sure one of the players will remind me as I am still in touch with several of them. I was at the games but my memory

is not as good as it once was.

In the first overtime period despite "thrilling action at both ends as both teams tried desperately to end the game" they remained deadlocked.

At the 11:36 mark of the sudden death overtime, Randy Carroll notched the winner.

In the second game, the Huskies took the lead in the first period on a goal by Gary Chambers but Blind River tied it up shortly thereafter. In the second their opponents took the lead, but David Freeborn got the equalizer.

In the first two periods the game was "free wheeling with great chances by both teams."

However, disaster seemed to strike in the third period as the Huskies has fallen behind by three goals.

But this team was no quitter. Trust me on this one as I was standing right behind the bench, and was as excited as I have ever been at a hockey game. What happened next counts among my great Chapleau hockey moments.

John Bernier scored to begin the comeback and nine minutes later Yves Gervais narrowed the margin to one goal. Shane Gillham was making outstanding

saves but time was running out on the Huskies.

With 48 seconds remaining in regulation time Randy Carroll scored assisted by Tim Morin and John Bernier, and the Huskies remained alive to play overtime.

For 18 minutes, the play was marked by end to end rushes and great performances by both goaltenders.

Then with two minutes remaining "big Michael Tremblay intercepted a clearing pass and scored an unassisted goal." The Huskies won 6-5, and were the NOHA champions.

The Chapleau team had defeated Matheson, Smooth Rock Falls and Englehart to reach the finals. Randy Carroll was mentioned as the "big man" scoring the

winner in first game and tying goal in second, but great credit also went to goaltender Shane Gillham. Tim Bernier and John Bernier each collected nine points.

Coaches Jamie Doyle and Mike Tangie had done an incredible job. Jamie had been working in Chapleau when the season started, but was transferred to Sudbury so travelled for games, while Mike was a constant steady hand. Jamie was also playing for the Chapleau Intermediate "A" Huskies.

My sincere thanks to Dan Tebbutt for taking the time to get me information on the series.

Just recently, Dan sent me the following:

"I play hockey with Greg White. He's

from the Soo and played for the Rapids in the 60's (in the international Junior 'B' Hockey League) and has shared some stories of playing the Huskies. He recently told me, 'Whenever we had a game in Chapleau, we needed three lines. One on the ice, one on the

bench and one down in the dressing room thawing out on the steam radiators!' Boy did that bring back some memories. That arena could be awfully cold in the dead of winter."



Mr. Palmer also addressed some concerns regarding a recent leak from a hose on one of its ice drills: "the hose contained no hazardous material,

only lake water and rock dust from drilling we've been doing on the ice." He said. "As soon as we noticed the leak we took measures to clean up the spill and ensure that First

Nation environmental monitors were onsite and the Ministry of Environment were satisfied with the results."

Mr. Palmer welcomed the questions and stated that input from the community is a very important part of the process. Public consultations will be an ongoing process.

The environment and its protection is a priority for Probe Mines and procedures used are compliant with the Ministry of the Environment.

The president of Probe Mines closed the presentation by stating his company's goal of making this a local project with the communities as key partners in its develop-

ment. As an example of this commitment, Probe has started working with the Chapleau Economic Development Corporation to look at the economic benefits and spinoffs of the project. Said Mayor Byham: "This mine is still a few years off and while it's not yet a sure thing, we felt it was important to start working together to make sure

that we're prepared to handle a project of this size and get the most from the benefits it could bring to Chapleau."

A team effort between the community and Probe mines will facilitate resolutions of possible upcoming issues and obstacles. Good planning on the part of the Township of Chapleau in regards to

infrastructure will be required sooner than later.

There is a long road ahead but it is one of encouragement and hope and it is with certainty that our community can and will work with Probe Mines to constructively forge ahead and ensure our future as a community and that of our children and grandchildren.

Changements au programme de transport médical du ministère de la santé

Le Réseau du mieux-être francophone du Nord de l'Ontario tient à partager une importante nouvelle à l'égard d'un changement apporté au programme de subvention accordée aux résidents du Nord de l'Ontario pour frais de transport à des fins médicales, programme connu par plusieurs comme 'Travel Grant'. À compter du 1er décembre dernier, l'octroi pour la portion d'hébergement est soumis à de nouveaux critères. Les patients qui doivent voyager au moins 200 kilomètres dans un sens pour se rendre chez le spécialiste le plus proche ou subir une intervention dans un établissement de soins doivent maintenant présenter un reçu pour leur hébergement qui servira à prouver qu'ils ont effectivement engagé la dépense.

Voici quelques questions et réponses de cette allocation d'hébergement tirées du

site Web www.health.gov.on.ca

Pourquoi faut-il dorénavant présenter un reçu pour être admissible à l'allocation d'hébergement?

Pour respecter l'engagement de prudence qu'a pris le gouvernement à l'égard des dépenses de fonds publics, le programme exige maintenant que l'on présente un reçu à des fins administratives et de vérification. Les reçus doivent être présentés pour les services médicaux prodigués le 1er décembre 2012 ou après cette date.

Quelles sont les formes de reçus acceptables? Puis-je présenter des copies?

Il faut présenter le reçu original détaillé. On entend par « reçu original détaillé » un reçu indiquant la liste des articles achetés et le prix individuel de chaque article, par exemple d'un hôtel ou d'un motel. Il s'agit habituellement du reçu

qui est imprimé par une caisse enregistreuse. Le reçu d'autorisation d'une carte de crédit ou de débit n'est pas un reçu détaillé.

À qui dois-je soumettre mes reçus?

Les reçus justifiant les frais d'hébergement doivent être envoyés avec votre formulaire de demande.

Faut-il avoir payé pour l'hébergement afin d'être admissible à l'allocation d'hébergement?

Afin d'être admissible à l'allocation d'hébergement, le patient doit aussi avoir engagé les frais d'hébergement et avoir présenté un reçu pour justifier le paiement.

Puis-je utiliser un programme de récompense, comme Air Miles, pour payer mon hébergement?

Oui, les milles de votre programme de récompense sont un mode de paiement acceptable, et il faut présenter un reçu détaillé.

Le reçu n'est pas en mon nom en tant que patient, sera-t-il accepté?

Non, le reçu doit être émis au nom du patient.

J'ai logé chez des parents/amis, suis-je admissible à l'allocation d'hébergement?

Non, si vous n'avez pas engagé des frais pour votre hébergement, vous n'avez pas droit à l'allocation d'hébergement.

Mon hébergement était pour une durée plus longue qu'une seule nuit, est-ce que l'allocation d'hébergement couvrira toute la durée de mon séjour?

Seule une allocation d'hébergement de 100 \$ est octroyée par déplacement admissible à des fins médicales – l'allocation n'est pas un remboursement et n'est pas calculée en fonction du nombre de nuits

d'hébergement.

Est-ce que les accompagnateurs sont dorénavant admissibles à l'allocation d'hébergement?

Non, les personnes qui vous accompagnent ne sont pas admissibles à l'allocation d'hébergement.

Est-ce que mes frais de repas, taxi, etc. seront pris en charge si je ne loge pas à l'hôtel?

Non, le programme ne couvre

pas les frais engagés pour les repas et les taxis.

J'ai perdu mon reçu et il m'est impossible de le remplacer. Pouvez-vous m'octroyer l'allocation d'hébergement?

Non, il est impossible d'octroyer l'allocation d'hébergement sans avoir le reçu pour justifier le paiement de l'hébergement.

Le spécialiste que l'on m'a dit de consulter est à une distance de

moins de 200 km, mais le spécialiste que j'ai consulté m'a demandé de ne pas prendre le volant et de passer la nuit sur place. J'ai le reçu pour la nuit d'hébergement à l'hôtel – suis-je admissible à l'allocation d'hébergement?

Non, vous n'êtes pas admissible à l'allocation d'hébergement. Vous devez avoir eu à parcourir une distance d'au moins 200 kilomètres dans un sens.



Licensing:

Standards, Legislation and Inspections

In Ontario, anyone who cares for six or more unrelated children under the age of 10 must be licensed by the Ministry of Education. This includes home-based child care and centre-based child care.

Licensed child care programs must meet and maintain specific provincial standards set out in the *Day Nurseries Act*. These standards provide for the health, safety & developmental needs of the children.

At least once a year, staff of the Ministry of Education make unannounced inspections of all licensed child care programs to:

- make sure that provincial standards are being met
- issue and renew licences
- investigate complaints

Taxpayers Federation Elated With Passage of Bill C-27

CTF's three-year push for disclosure of aboriginal politicians' salaries pays off, bill will improve accountability

The Canadian Taxpayers Federation (CTF) applauded the federal government for passing and proclaiming Bill C-27 today; legislation that will require aboriginal politicians on all reserves in Canada to disclose their salaries to the public (just like every other politician in the country). The CTF first began

pushing for such a change back on December 22, 2009.

"We're ecstatic this bill has become law as we've pushed hard for it over the last three years," said CTF Prairie Director Colin Craig. "Plain and simple, aboriginal politicians should have to disclose their pay to the public just like all other politi-

cians in the country. The federal government deserves praise for addressing this issue."

"We really tip our hat to the brave men and women on reserves who have risked a lot to leak documents or speak out," added Craig. "Most people don't understand it, but it can be really difficult

to speak out on reserves. This legislation will help people on reserves hold their officials accountable."

The CTF began pushing for the bill back in December 2009 when Phyllis Sutherland, a whistleblower from the Peguis First Nation, provided copies of outrageous pay information from her community. At the time, the chief and council from the small

community of 3,700 were making more in pay, or close to Prime Minister Stephen Harper's salary.

The story from took on national attention and soon after the CTF was flooded with calls and emails from people living on reserves across the country.

"People either had documents to leak or wanted help getting access to their band's financial statements.

We knew we had to keep pushing hard on this issue," continued Craig.

The CTF also noted the bill will help clear the names of the many good chiefs and councillors out there who aren't taking exorbitant pay cheques, but have been painted with the same brush. Disclosure will help everyone sort out who is taking advantage of the system and who isn't.
